Corsair Darts World Cup Championship Terms & Conditions –November 2025

- 1) The “Promoter” is VIP Computer Centre Ltd (Registration no. 2552402) whose registered office is at VIP House, 4 Hardwick Grange, Warrington, WA1 4RF.
- 2) This incentive is open to select customers of VIP Computer Centre Ltd, who are UK residents aged 18 years plus and whose business purchases Corsair from VIP.
- 3) By making qualifying purchases of Corsair products that give entry into the prize draw resellers are indicating their agreement to be bound by these terms and conditions.
- 4) There are 2 more places at the World Darts Championships on Tuesday 16th December at the Alexandra Palace in London with darts hospitality and overnight accommodation available to be won. The 2 winning customers will be selected at random in the prize draw. Each order containing Corsair items that total £200+ made between the 11th and 21st November 2025 will provide an entry into the prize draw. Additional orders, provides multiple entries. Winners will be confirmed by 26th November. The World Darts Championships VIP event takes place on the 16th December 2025. The date is non-negotiable and non-transferable.
